#### **1. MEETING DETAILS**

#### **2. CALL TO ORDER**

The meeting was called to order by Paul Rudolph at 10:52 AM.

The meeting agenda was distributed to Board Members.

#### **3. ROLL CALL**

A quorum was confirmed with the following members in attendance:

No recorded absentees. All members were present.

#### **4. APPROVAL OF PRIOR MEETING MINUTES**

The approval of minutes from the March 24, 2026 meeting were skipped because of this meeting being so close to this meeting.

#### **5. NUMBER OF VOTING MACHINE, POLL PADS & WORKERS FOR ELECTION DAY**

Paul stated that at a majority of polling locations there would be a default of 5 people, 2 poll pads and 4 machines. Locations to receive the default are: Elberfeld Fire Station, Lynnville Community Center, Pigeon Township Community Center, Folsomville United Methodist Church, Tennyson Community Center, Quail Crossing Country Club, Warrick County FOP, Newburgh Healthcare, United Steelworkers Local 104 and Zoar United Church of Christ. After discussion it was agreed on that the following polling locations would have: Boonville-Warrick County Public Library – 7 people, 4 poll pads, 6 machines; Warrick County 4-H Center – 5 people, 2 poll pads, 6 machines; Chandler Community Center – 5 people, 3 poll pads, 6 machines; Living Word Christian Church – 7 people, 4 poll pads, 10 machines; Ohio Township Community Center – 7 people, 4 poll pads, 8 machines; American Legion Kapperman Post #44 – 7 people, 4 poll pads, 8 machines; Friedman Park Event Center – 5 people, 3 poll pads, 6 machines. Mike stated he totals are 93 people, 44 poll pads and 90 machines. Paul stated he had the same totals. Paul made a motion to approved the number of people at 93, the number of poll pads at 44, and the number of machines at 90, seconded by Mike, motion carried 3-0.

#### **6. ADDITIONAL BUSINESS**

- a. MIKE – Mike stated the poll worker training is today @ 1:00 p.m.
- b. NANCY – Nothing at this time.

- c. PAUL – Paul stated nothing at this time except for scheduling the next Election Board meeting. Paul stated the Board would get together and determine a date for the next meeting at a later time.

No public comment

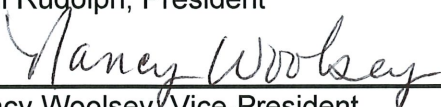
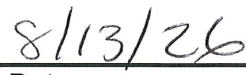
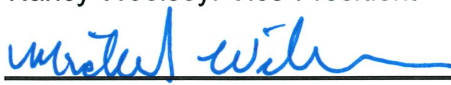
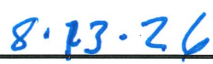
**8. ADJOURNMENT**
